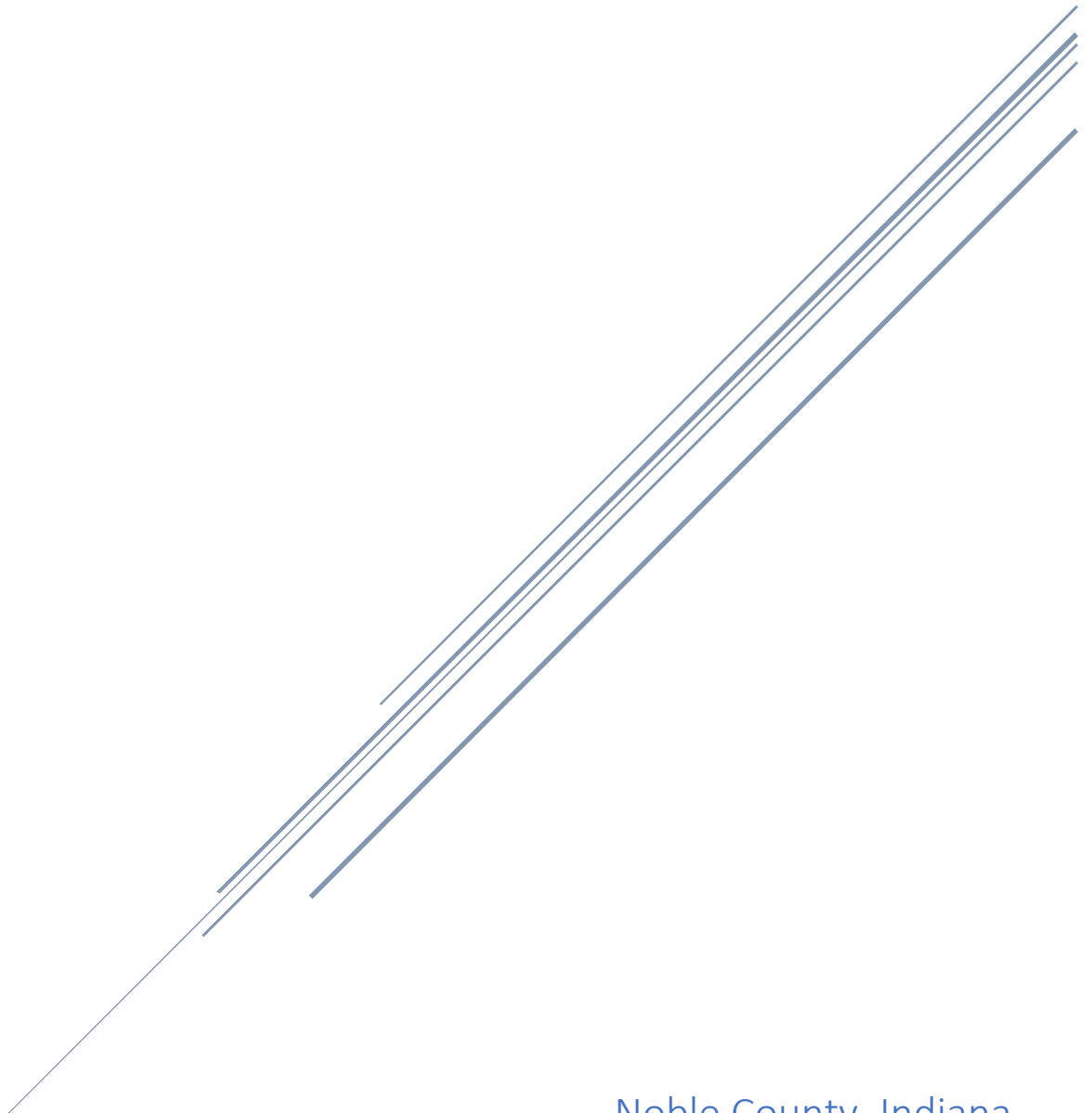


Adoption Resolution



The Planning Area

Located in Northeast Indiana, Noble County covers 412 square miles of land, and is northwest of Fort Wayne.

The Parks Board of Noble County is responsible for all of the unincorporated areas of Noble County outside of the incorporated communities of Albion, Avilla, Cromwell, Kendallville, Ligonier, Rome City, and Wolcottville.

The Park Board

The Park Board was created in 2010 by Ordinance of the Noble County Council in response to a part of the 2007 Noble County Comprehensive Plan. The board consists of six people, two appointed by the Judge of the Circuit Court, two by the County Council, one by the Board of Commissioners, and one by the Purdue County Extension Agent.

Population Trends

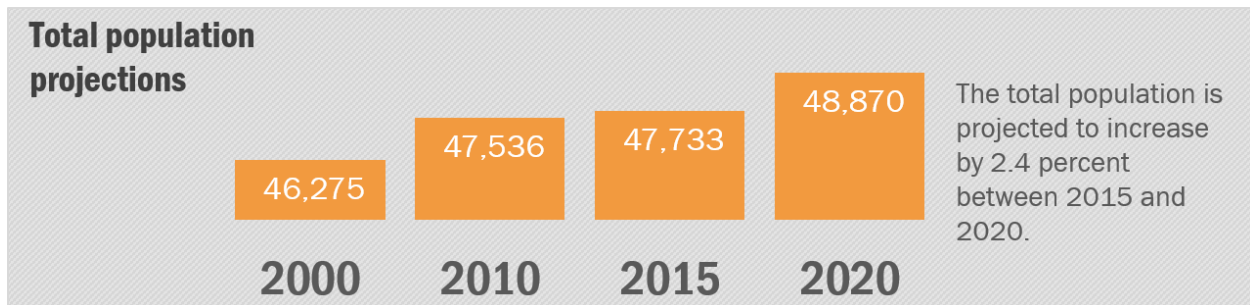


Figure 1 Population Projections from Purdue Data Snapshot

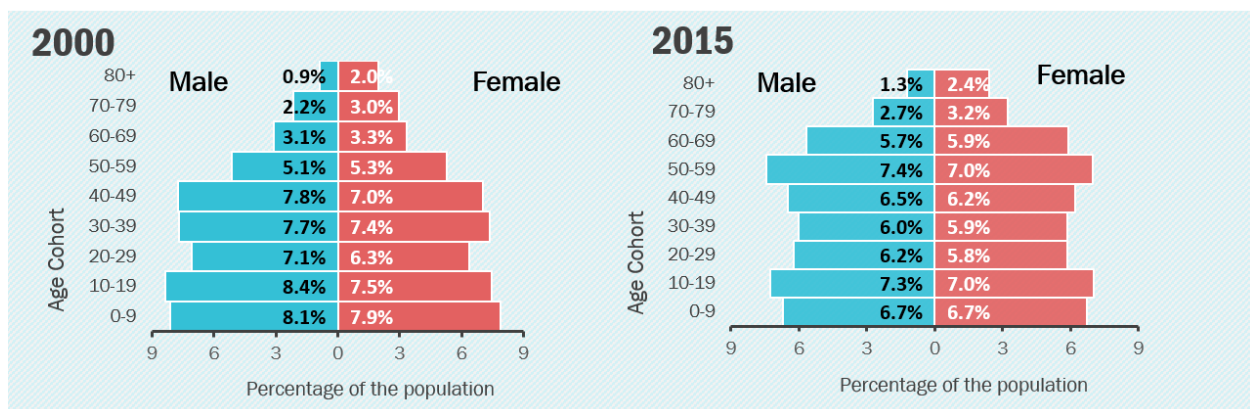


Figure 2 Population Pyramid from Purdue Data Snapshot

Noble County experiences a challenge unlike most other communities in rural Indiana where the concentration of people is so spread out. Over 56% of the population of Noble County lives outside any municipal limits and receives services from Noble County. (43.95% or about 20,900 people live within corporate limits of a town or city.) This demographic composition increases the importance of evaluating future parks and recreational areas in unincorporated areas of Noble County.

Socio-Economic Factors

The economic base of Noble County is manufacturing with all five of the largest employers being manufacturers.

Since 2001, Noble County median household income has fallen by more than \$3,000 while per capita income has increased by nearly \$3,000. This can indicate that more households are consisting of a single-earner instead of two-earner households.

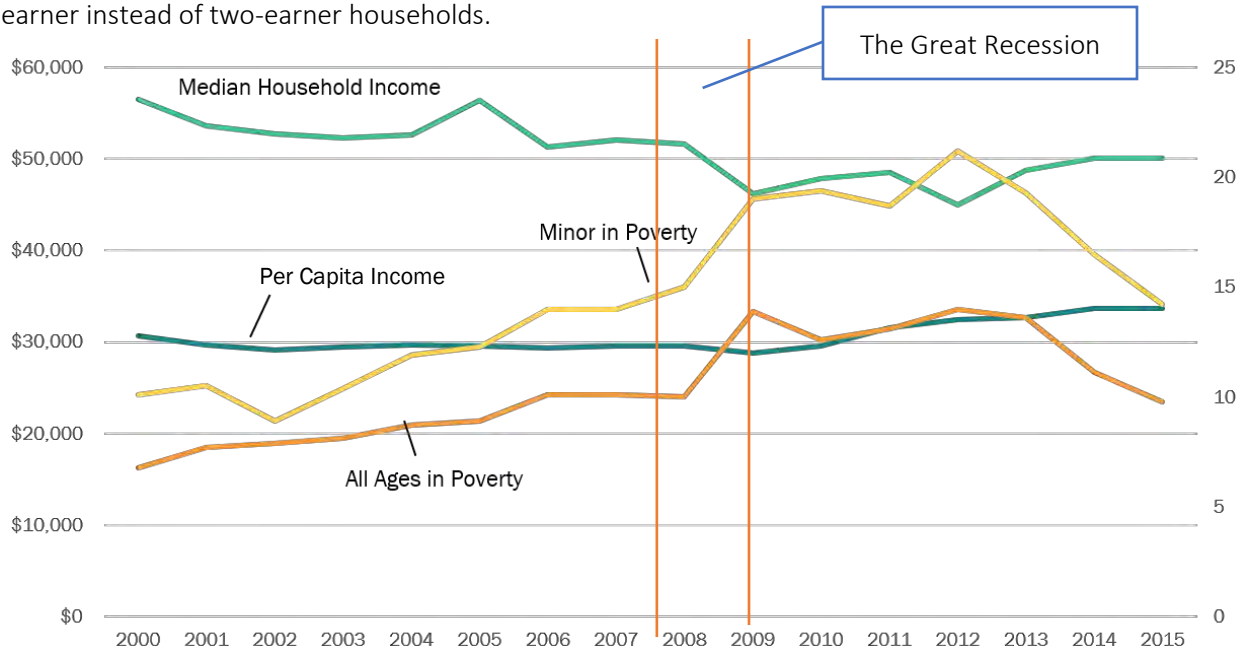


Figure 6 Income Graph from Purdue Data Snapshot

Of note is the minority majority population in the City of Ligonier where over half of the Hispanic or Latino community resides. This segment accounts for 59.9% of the city’s population.

Natural Features & Landscape

Lakes

Within Noble County lie 117 lakes. However, many of these lakes have no public access, and are surrounded by private owners, including lake homes and cabins. Major natural lakes in Noble County include:

Baughner Lake, Engle Lake, Muncie Lake, Bear Lake, Henderson Lake, Round Lake, Big Lake, High Lake, Skinner Lake, Bixler Lake, Jones Lake, Smalley Lake, Chain O’Lakes, Knapp Lake, Upper Long Lake, Crooked Lake, Little Long Lake, Waldron Lake, Deer Lake, Lower Long Lake, Williams Lake

Sylvan Lake is the only substantial manmade lake in the county, with the dam at Rome City creating the 669-acre lake, 16 miles of shoreline, and has a public access site.

Rivers & Streams

The Elkhart River is the principal drainage outlet for Noble County. It was formed by the confluence of the North Branch Elkhart River and the South Branch Elkhart River at a point about 3.5 miles east of Ligonier, Indiana. The Elkhart River flows northwestward to its junction with the St. Joseph River in Elkhart, Indiana. About 10 miles of this river are in Noble County with about 36 miles downstream of the county line. At the county line the Elkhart River drainage area is 303 sq. miles. The other 9 streams within the St. Joseph River sub-basin flowing from Noble County include Little Elkhart Creek, Solomon Creek, and Turkey Creek. Seventy-five percent of the Noble County lies within this sub-basin. Flow characteristics of this area are perennial by nature, due principally to substantial areas of wetlands, natural lakes, and groundwater reservoirs.

Noble County lies along the eastern continental divide and thereby fall along the upper watershed of several major drainage basins. The natural stream system in the upper watersheds is largely comprised of

channels connecting the many natural lakes. These channels are inherently shallow streams meandering through marsh lands.

The Tippecanoe River drainage area (part of the Wabash River sub-basin of the Ohio River basin) is 36 sq. miles, makes up approximately 10% of Noble County, and is located in the southwest corner of the county. Like the St. Joseph River sub-basin area, flow is perennial and natural lakes are a dominant landscape feature. Wilmot Pond is the only major artificial lake.

In the southeast corner of the county, Sycamore Creek, Little Cedar Creek, Black Creek, and Willow Creek all drain to the Maumee River sub-basin of the Great Lakes basin. Fifteen percent of the county lies in this sub-basin. Little Cedar Creek has headwaters in adjacent DeKalb County and after only about two miles in Noble County returns to DeKalb County. This stream has about 35 sq. miles of drainage area. The other three streams mentioned above originate in Noble County.

Topography

Noble County topography is more rolling, and consequently fluctuation in stream flow is more pronounced. Green Township is significantly hilly while Perry Township is relatively flat.

Vegetation

The natural vegetation types that are found within this region include broadleaf forests, oak savannas and a variety of prairie communities. In addition, another form of vegetation listed in the “Noble County USDA Soil Report” is trees/timber (woody vegetation). Almost half of the area is currently covered by corn or soybean agriculture and more than a quarter of the area is dedicated to pasture, hay and mixed crops.

Soils

The “USDA Soil Conservation Service Report” in cooperation of Purdue University indicates a wide range of soil types throughout Noble County. Close to 50 percent of the soils are Blount silt loam, Fox Sandy loam, Houghton muck, drained, Miami and Morley silt loam, Pewamo silty clay loam, Riddles sandy and Sebewa loam. Slopes can range anywhere from 0 to 25 percent depending on the area, but the average slope runs between 2 to 6, and 6 to 12 percent. The Noble County Parks and Recreation Department will want to consider soil types and building restrictions when determining future parks and recreational sites (“Noble County USDA Soil Report” pg. 11).

Flood Plains

Land use in the flood plains of unincorporated Noble County is of relatively low agricultural intensity with about one-fourth of floodplains in cropland. The wetlands occupy about one-third of the flood plain and are marshy or swamped areas. Grassland, forest land and other land account for the balance. Several residences and a few businesses are located in flood-prone areas throughout the county. Concentrations of houses in flood-prone areas occur near certain lakes. The Noble County Plan Commission and Zoning Administrator are responsible for the management of floodplain activity.

Implications

The wide diversity of Noble County's topography and natural lakes provides a unique opportunity to for incorporating the waters of Noble County into parks and recreation efforts. Both on the lakes and along the rivers and streams of our county, water-based recreation is and will continue to play an important role in the recreation enjoyed by residents and visitors. The many forests of Noble County also offer an opportunity for passive recreation while also conserving precious land in our community.

The Merry Lea Environmental Center of Goshen College in Noble Township covers over 1,100 acres in Noble Township near High and Bear Lakes and includes miles of nature trails.

Noble Trails is beginning to expand the Fishing Line Trail south from Kendallville to Avilla.

Chapter 2—Demand Analysis

Random Citizen Input

As part of the planning process, a survey was created and shared throughout Noble County by the Noble County Government Facebook and by the Noble County Parks Board. Results of the survey are included in the appendix.

The survey was distributed solely online and received 43 responses between it opening in mid-October and it closing on December 5.

The most prevalent information from the community survey included a desire to increase the miles of walking trails available and provide opportunities for canoe/kayak experiences through passive recreation.

Opportunities that the community did not believe the parks board should support included field and court sports, ice skating, a splash pad, or a campground.

Community Meeting

On December 5, 2018 the Parks Board held a park planning meeting with the public. Attendance is documented in the appendix. The attendants discussed two primary needs: 1) to publicize the opportunities for recreation, and 2) increase the miles of trails which will connect communities.

The attendance largely consisted of parks board members but the parks board also brought in discussion from individuals that came at the end of the meeting for the Board of Zoning Appeals which was held right after the Parks Meeting. The public made comments concerning:

- Increasing the availability of trails
- Publicizing the availability of recreational opportunities
- Ensuring safety of the trail users

Stakeholder Input

In order to better understand the needs for Noble County, the plan author scheduled meetings with a wide variety of stakeholders to discuss the parks plan and needs. These groups included:

- Parks Superintendents of Noble County's Cities and Towns
- Noble Trails, Inc. Board
- ACRES Inc.
- Environmental Educator for Merry Lea Environmental Center of Goshen College

Recommendation

The Noble County Parks Board recommends that is continued to advocate for recreation opportunities throughout the county and to promote the existing excellent facilities. The Parks Board will continue to work with other government and citizen groups to fulfill the unmet needs of the residents of Noble County.

Action 1—Increase the Miles of Trails

There is a clear need for trails in Noble County based on resident input and its ability to improve quality of life and place. The following action steps are part of the strategy to increase the availability of trails in Noble County.

1a—Develop south branch of the Fishing Line Trail between Allen County and Kendallville

This component of the action comes from the Indiana Department of Natural Resources State Trails Plan.

Cost	\$400,000 per mile of trail between Allen County, through LaOtto, to Avilla \$100,000 per mile of trail between Avilla and Kendallville using I&M Land/Easements <i>Approximately 11 miles of trail</i>

1b—Develop a Trail Head for the Fishing Line Trail

As part of a complete trail system, trail heads will be needed to accommodate people’s use of the trail system. The trail heads should have parking, restrooms, and a place to fill water bottles. It could also be useful to include a quick bike repair station.

1c—Install Emergency Trail Markers Along Trails

In order to provide safety for trail users, emergency trail markers are necessary.

1d—Accept Maintenance for Existing Trails

By accepting maintenance for existing trails developed by other groups like Noble Trails, those groups will be able to continue to focus on their mission of adding miles of trails.

1e—Partner with Noble Trails and Municipalities to Build Trails

Priority Trailways:

- Engle Lake Trail (between Ligonier and West Noble Schools along Engle Lake)
- Other trails as identified in Parks Plan Map

Action 2—Develop Water Based Recreational Opportunities on the Elkhart River

The beautiful Elkhart River can be used as a recreational asset for our residents and visitors to our communities. The stretch between Dukes Bridge and Cosperville can be developed for kayak and canoe use. This would include:

- Obtaining easement rights to use the river beyond normal riparian rights
- Obtain land in Cosperville for a trailhead and installing a kayak/canoe launch
- Developing trailheads at Dukes Bridge and Cosperville
- Cleaning the Elkhart River of obstructions & weeds
- Installing signage for the trail

Cost	\$250,000



The results can be viewed in the appendix to this document.


Public Meeting

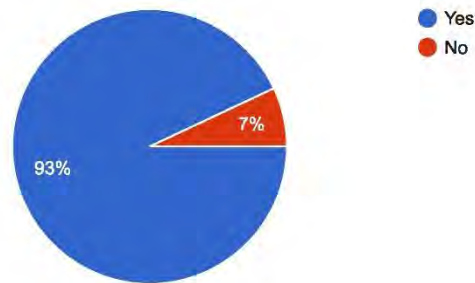

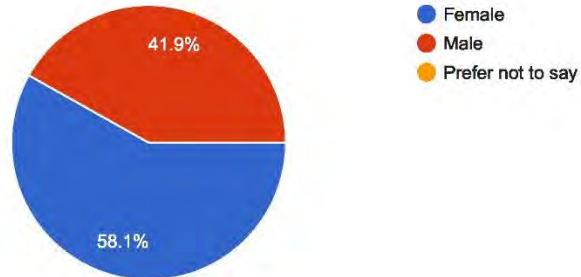

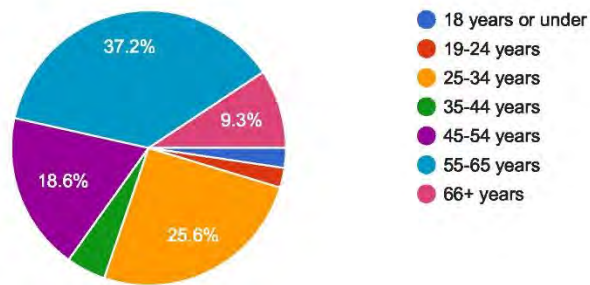

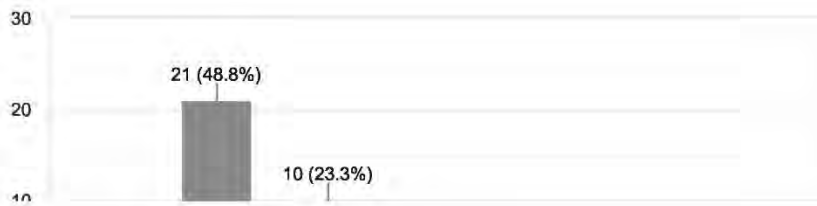

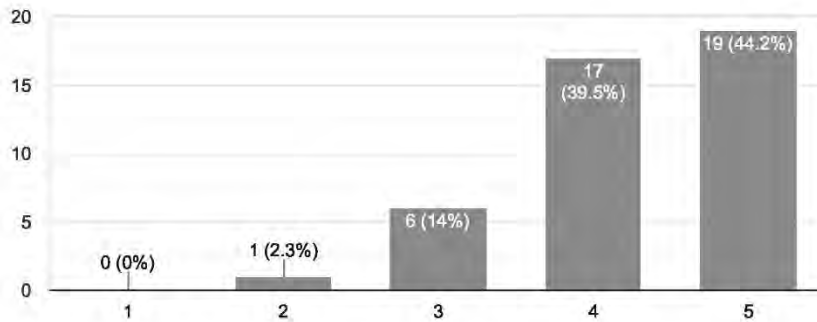

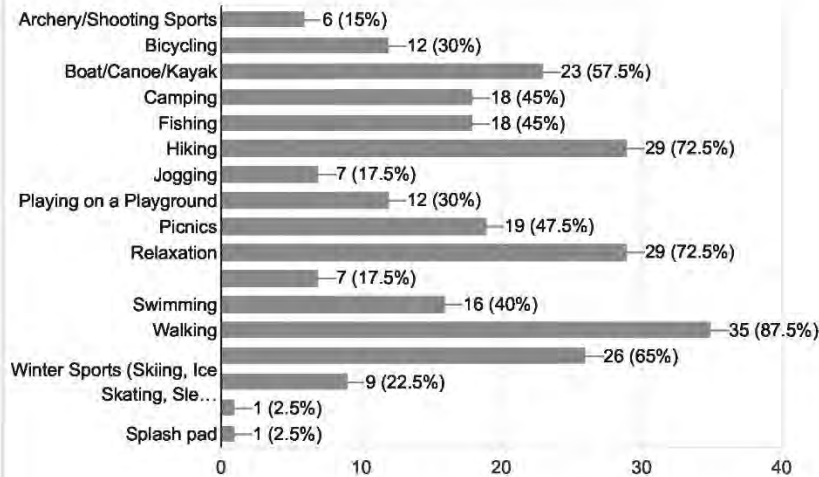

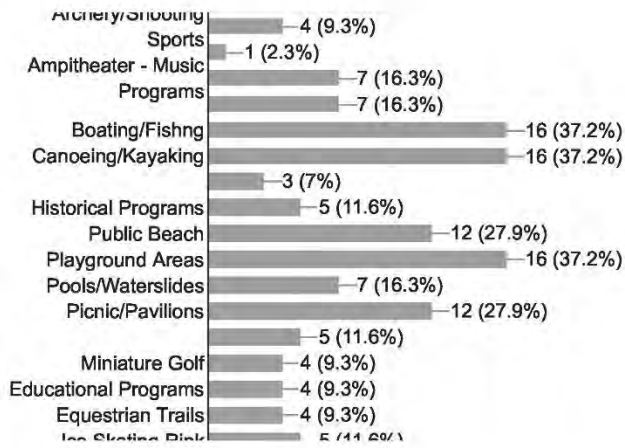

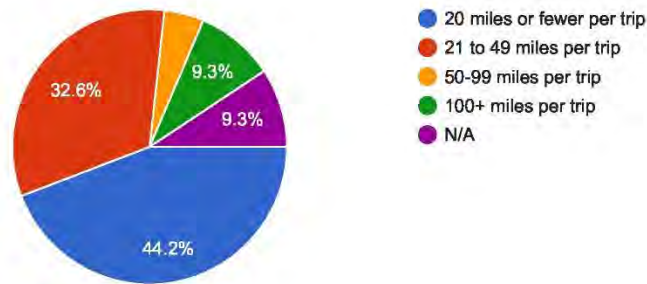

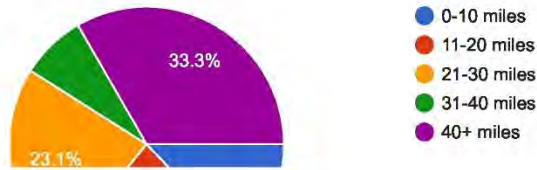

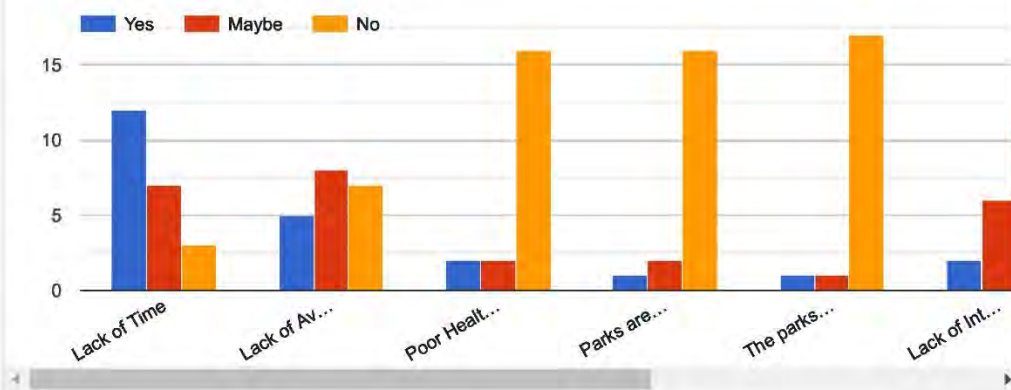


How far are you willing to travel to reach your favorite park or recreational area?

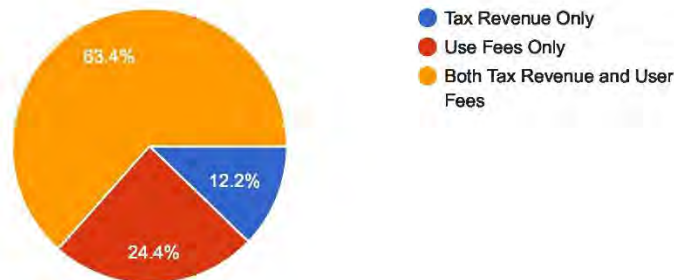

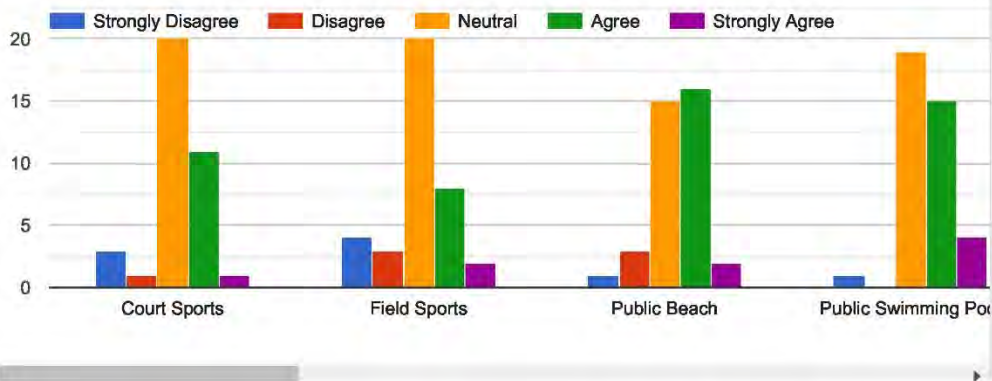

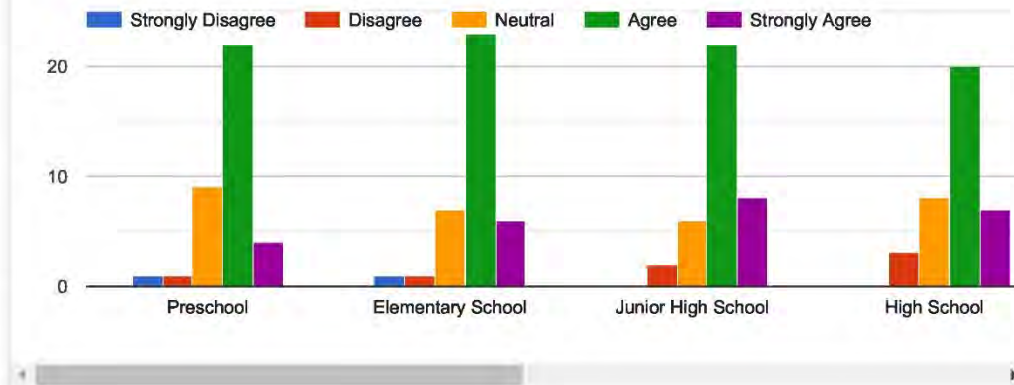

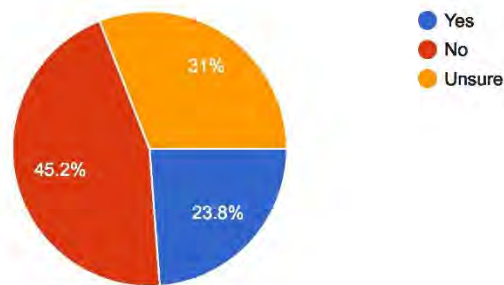

Plan director offers help to park board

Noble County Park Board could become grant eligible

ALBION — Game changer.

On Wednesday, moments after two Noble County Park Board members discussed the idea of letting its five-year master plan lapse, in came Noble County Plan Director Kenneth Hughes riding a figurative white horse.

Hughes had park board members doing an about-face on the idea of updating their plan after offering his department’s assistance — including money to fund the effort.



The Park Board took no formal action on Hughes’ offer of assistance, but said they were receptive to the idea. A vote on the matter could come as early as the board’s March 28 meeting.

The Park Board had discussed not updating its five-year master plan, which runs out in 2019, at its meeting in January. At that time, members questioned the need. With no budget, the park board wasn’t able to apply for any grants, which normally include a local match that the board could not foresee being able to come up with.

A current five-year master plan is a requirement for applying for state grants through the Indiana Department of Natural Resources.

The Park Board would have had to apply for local grants to get the five-year master plan updated. With no prospects of giving anything back to the community in the form of grants, the board seemed to be leaning toward letting the master plan lapse without asking for the approximately \$10,000 it would take to do the project itself.

“We don’t want to keep going to the well and then not do anything,” board member John Metzger said at Wednesday’s meeting.

Then Hughes spoke, and changed everything.

He said he had a small pool of money he could use to pay for an update to the master plan.

“I think it’s enough to get an update done that meets DNR requirements,” Hughes said. “I wouldn’t want to see the park board close the door on funding.”

By doing the update in conjunction with the ongoing Noble County master plan, Hughes said it would be good timing.

“Parks are a big component” in quality of life, Hughes told the park board. “It is very clear we want a more walkable community.”

Hughes said the Noble County Park Board, if it has a current five-year master plan, could apply for grants by collaborating with a non-profit group such as Noble Trails. For example, the matching portion for a grant could come from funds Noble Trails has already invested in a project.

Hughes said he could also possibly assist in the grant application process.

The Noble County Park Board was established by a Noble County Council resolution in 2010 as an unfunded government body.

“We’ve done fairly well in spite of that,” board president Ray Scott said.

The board has been doing what it can to promote recreational opportunities in Noble County, including the creation of a website with an interactive map showing such things as golf courses, parks and trails. The board has also hosted a walking program.

Doing such things without any money has been problematic.

“We’ve been struggling,” Metzger said. “No doubt about it. We’re still struggling to get people to know what we have here.”

Also at Wednesday’s meeting, the board set tentative dates and locations for its Take a Stroll Saturday program.

Events have been preliminary scheduled for:

- May 26 at Parkview Noble Hospital’s walking trail — in partnership with the Parkview Noble Hospital Center for Healthy Living;
- June 2 at the Fishing Line Trail near Rome City — in partnership with Noble Trails.
- July 28 on the Elkhart River — the canoe/kayaking event will be held in partnership with the West Lakes Association;
- Aug. 25 at Bixler Lake Park in Kendallville — held as part of a barbecue cook-off event in partnership with the Kendallville Parks and Recreation Board; and
- Sept. 22 at Chain O’ Lakes State Park — held in partnership with the state park on its National Public Land Day. There is no admission to the park on this date.

County parks board to update master plan

ALBION — The Noble County Park Board will be upgrading its five-year master plan.

The board had been on the verge of letting its current plan lapse, or at least seemed to be leaning that way at meetings in January and February. Having a master plan is a necessity for applying for state grants. Since the group had no matching funds available to apply for state grants, some board members considered it unnecessary to go through the expense and work of updating its master plan.

But at the group's February meeting, Noble County Plan Director Kenneth Hughes offered to have his office do the work. Hughes pointed out that by working in conjunction with non-profits, the Noble County Park Board could use work done by those non-profits as its share of matching funds in making grant applications.



During Wednesday's meeting at the Noble County Public Library Central Branch in Albion, board member Scott Allen motioned to have Hughes' office do the work. Board member John Metzger made the second, and the measure passed unanimously.

The work will be done in conjunction with Noble County updating its master plan.

"It's great we're going to be part of that process," board president Ray Scott said.

The board also finalized its plans for its Take a Stroll Saturday program, an effort to get people walking outside and to showcase the outdoor recreational opportunities available in Noble County.

Those walks will be:

- May 19 at Parkview Noble Hospital's walking trail — in partnership with the Parkview Noble Hospital Center for Healthy Living;
- June 2 at the Fishing Line Trail near Rome City — in partnership with Noble Trails.
- July 28 on the Elkhart River — the canoe/kayaking event will be held in partnership with the West Lakes Association;
- Aug. 25 at Bixler Lake Park in Kendallville — held as part of a barbecue cook-off event in partnership with the Kendallville Parks and Recreation Board; and

• Sept. 22 at Chain O' Lakes State Park — held in partnership with the state park on its National Public Land Day. There is no admission to the park on this date.

Allen also updated the board on Noble Trails second annual 5K event.

The registration period for the 2018 Fishing Line Trail 5K Run/Walk is now open.

The 5K Run/Walk will be held on Saturday, April 28, with registration and check-in opening at 7 a.m., and the race starting at 8 a.m.

The race will begin at the Gene Stratton Porter State Historic Site in Rome City. Duplicating last year's race, the route follows a section of local roads before entering the Fishing Line Trail. The race then travels back to the finish line at Gene Stratton-Porter.

County park board notes outdoor activities

ALBION — People are taking advantage of outdoor recreational activities in Noble County.

Even if they aren't so much participating in the Noble County Park Board's "Take a Stroll Saturday" initiative.

During the Aug. 22 meeting of the park board, member James Haddock announced that five people participated in the kayak event held in late July on the Elkhart River close to the West Lakes Chain. One of those participants was park board member John Metzger.



While turnout for the actual event wasn't what was hoped, Haddock and Metzger both reported plenty of activity on the river.

Metzger came across several bass fisherman who were participating in a local tourney. The tournament itself was centered on a local lake, but multiple boats ventured onto the Elkhart River to try their luck at finding bass on that body of water.

The event was held in conjunction with the West Lakes Association, which had planned a river clean-up event. Haddock estimated that 35 people were helping clear the river of debris, with the goal of facilitating water flow downriver from where flooding has occurred on the chain.

"They were up to their chests in seaweed and muck, pulling out branches," Haddock told the board. "They were an organized group."

Haddock also updated the board on a proposed Noble County Lakes Council. An informational meeting discussing the creation of such a council was held Aug. 2 at the Orange Township in Rome City.

The group seems likely to focus on water quality and clarity, flooding and vegetation and sediment control as some of its top priorities.

The idea for a countywide lakes council was one of several ideas residents on the flood-prone West Lakes chain west of Rome City came up with as they banded together to find ways to address their own situation. In coming up with a Top 10 list of priorities, they realized the main issues they wanted to address were more universal than just their section of the county.

Haddock said working with the council as it forms seems a good fit for the Noble County Park Board.

"Our common interest is use of these waterways," Haddock said. "I think it's a good thing."

Board member Scott Allen reported that the final property had been obtained by Noble Trails to finish paving from Angling Road north of Kendallville to the Gene Stratton Porter State Historical Site, a distance of approximately 5-6 miles.

Noble County Plan Director Kenneth Hughes was impressed with what the non-profit had been able to accomplish.

“The sheer magnitude of what they’ve been able to do is amazing,” Hughes said.

Hughes was on-hand to update the park board on the progress he was making in regards to its master plan.

Hughes said a 75-percent draft would be finished by mid-October. Before the park board can finalize its plans, it has to conduct a survey of what county residents want to see as far as county recreational opportunities. A public meeting must also be held.

The board’s master plan needs to be completed by Jan. 15. Completing a master plan is required to make the board eligible to partner with other groups, such as Noble Trails in pursuing state grants.

County park board reviews long-term plan

ALBION — The Noble County Park Board has tweaked its vision of the future.

During Wednesday’s discussion of the board’s five-year master plan presented by Noble County Plan Director Kenneth Hughes, the board discussed adding an item to its action plan.

The preliminary draft submitted for discussion by Hughes listed four action plan items:



- Publicize recreation assets by partnering with the Noble County Convention and Visitors Bureau and GIS Department;
- Work with health leaders to address health issues such as obesity and diabetes by working with the Noble County Health Department and Parkview Noble Hospital;
- Work with child development leaders to focus on programs for child enrichment, partnering with the Dekko Foundation and Community Foundation of Noble County; and
- Increase the miles of trails available to residents by working with Noble Trails and municipal parks departments.

Board member James Haddock suggested adding an action item related trails of the aquatic variety.

“I would like to see an increased emphasis ... for the development of the Elkhart River for recreational purposes,” Haddock said. “I think there’s an increased public interest in it.”



Among other attributes, Noble County is known for its lakes, which draw visitors and residents for recreational purposes.

“I think we already have a good emphasis on lakes,” Haddock said. “I’m talking about flowing waters.”

Haddock and board member John Metzger pointed to progress currently being made by the West Lakes Association to clear the Elkhart River. Clearing the river will decrease flooding, but will also make the river more navigable for people in boats and canoes.

“At least there’s some activity,” Metzger said.


“It’s an asset,” Hughes said. “It needs to be used as one.”

The Noble County Park Board has no funding and no revenue source, so the board primary focuses on support of local recreation and outdoor options in the county as opposed to working on capital projects such as building trails or establishing playgrounds like a city park board funded by tax dollars might.

The board is still seeking input from the public on what community residents want to see as far as recreational offerings in the county. A survey is accessible online at bit.ly/NobleParksPlan, or can be accessed through the Board’s website at noblecoparks.wixsite.com/website. The survey can also be found through a link on the Noble County Facebook page.

The issue of the park department taking over maintenance of the Noble Trails Inc.’s trail system was also discussed. Board member Scott Allen said he did not see that happening until the board could show the Noble County Council the direct financial and economic impact the system has on Noble County.

County parks master plan on schedule

ALBION — The Noble County Park Board’s five-year master plan is on schedule, according to Noble County Plan Director Kenneth Hughes.

Hughes updated the board at its meeting held Wednesday at the Noble County Public Library’s Central Branch in Albion.

A draft of the plan needs to be sent to the Indiana Department of Natural Resources by Jan. 15, 2019. The final draft must be submitted by April 15, 2019. The master plan is a blueprint, of sorts, that the board will follow as it sets its coming agenda for the next five years.



A completed five-year master plan on file with the DNR is a requirement to make the park board eligible for certain state grants.

“We’re on track,” Hughes told the board. “As far as the DNR is concerned, we are going to have a compliant plan.”

As part of the requirements for the plan’s acceptance, the park board has scheduled a public input session for 6 p.m. on Dec. 5 in the Dekko Room at the Noble County Office Complex-South. Public input is important in determining the board’s direction as it shapes its master plan.

Hughes has also been researching ways to address the park board’s main obstacle — lack of funding.

The board was approved as a non-funded entity by the Noble County Council. Hughes would like to see that changed.

Hughes has begun taking a sampling of what other counties do as far as funding their county parks. Counties that do fund a countywide system generally fund it to the tune of between \$6-\$7 per capita, Hughes said. LaGrange County’s park system is funded at a rate of \$12 per capita, according to Hughes.



Hughes said he will broach the idea of starting at perhaps \$2 per capita with the Noble County Council this January. There is no guarantee the council will agree to any funding.

“That’s a very initial early thought,” Hughes said.

A preliminary part of the five-year master plan for the Noble County Park Board would involve an ambitious project concerning the Elkhart River. The action item would involve purchasing the title to the river bed from Duke’s Bridge to Cosperville, allowing the park board to create a canoe/kayak trail along that stretch of the river.

Duke’s Bridge is located on C.R. 125W, midway between C.R. 900N and C.R. 1050N.

The idea came about from a meeting Hughes had with a member of the Acres Land Trust.

“We mainly focused on the Elkhart River, mainly looking at it like a river trail,” Hughes said.

The board has taken no action on the idea, and would need significant funding to make it a reality.

Diann Scott, president of the West Lakes Association, was in attendance at Wednesday’s meeting, and she requested to be kept in the loop about projects like this within the West Lakes Area.

“We’re working a lot on the same things,” Scott said.

She said her group was attempting to purchase rights-of-way to certain sections along that proposed trail to allow for access to workers to help clean up that area to keep the water moving freely.

Scott said work is continuing on the creation of a conservancy district for the West Lakes area. If created, the conservancy district would become a taxing body which would enable it to collect taxes.

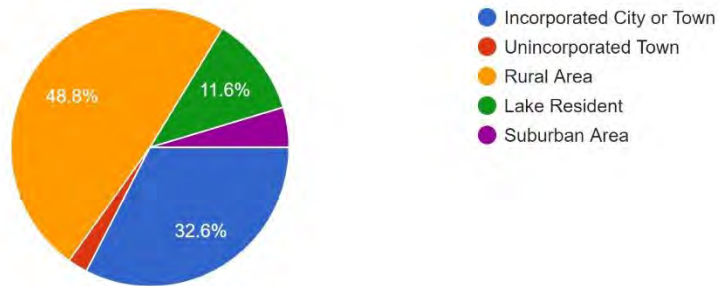
Do you live in Noble County?

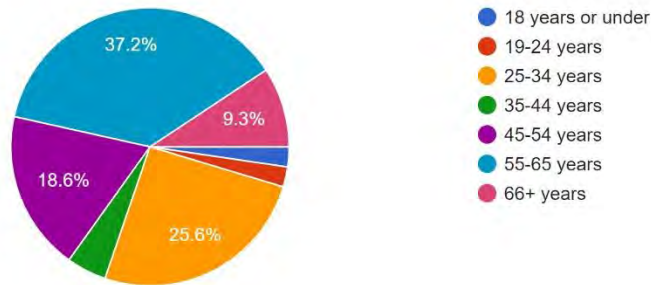
Which best describes where you live?

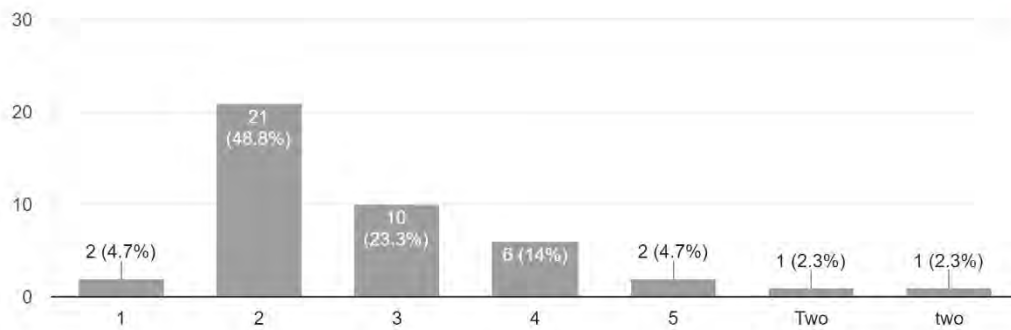
What is your age?

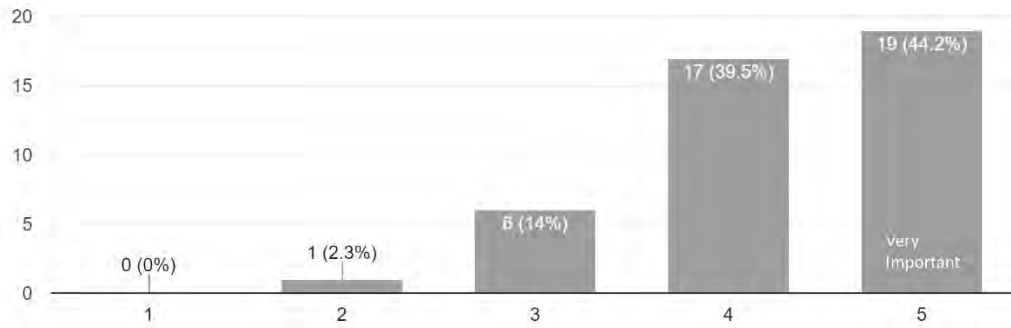

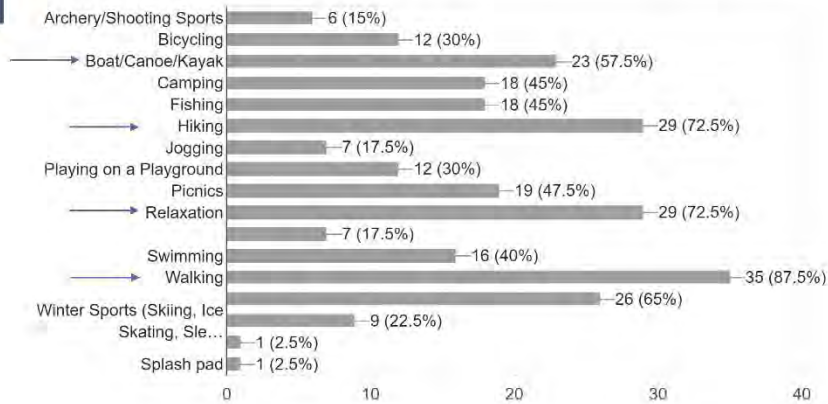
How Important is outdoor recreation to you?

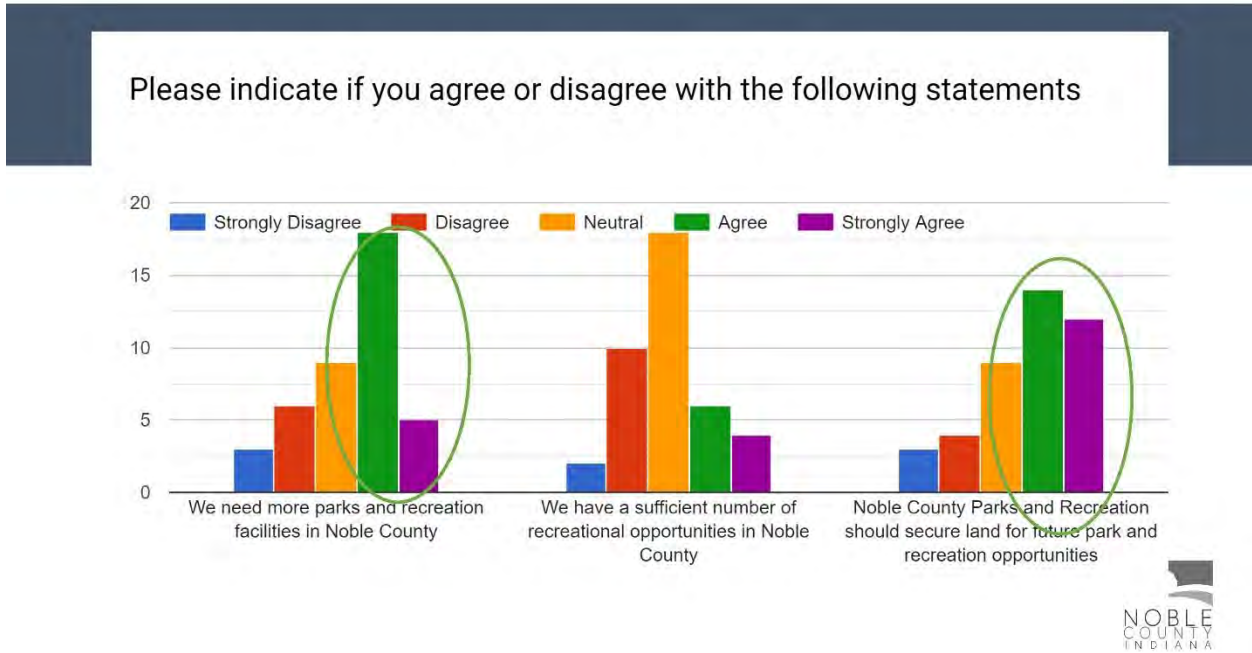
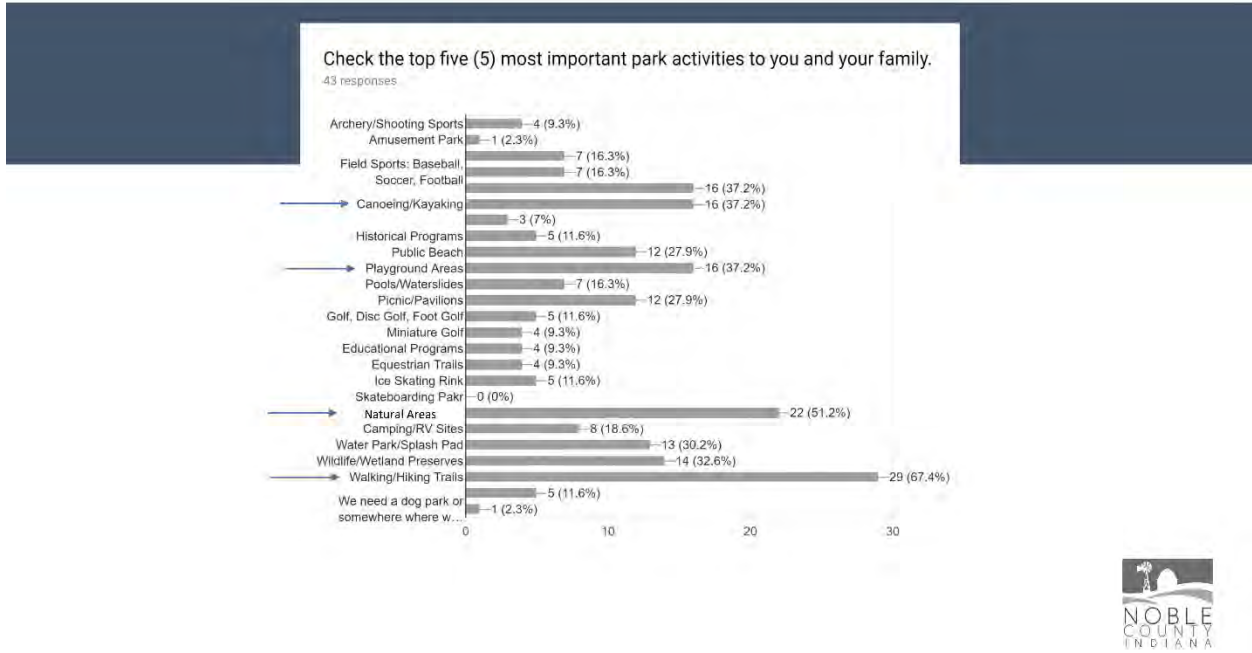

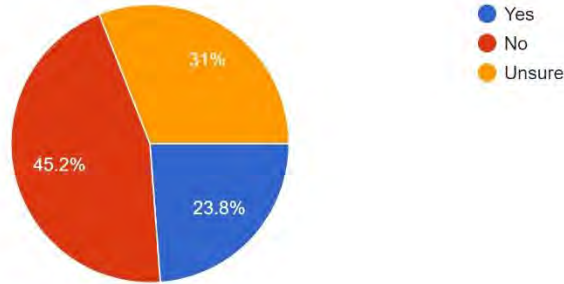
