Residents and businesses called to act for broadband

Noble County Economic Development (EDC) encourages residents and businesses who live and operate outside of incorporated communities in rural Noble County to participate in a pair of "speed tests" to measure and record, by address, current Internet speeds. The Indiana Speed Test takes less than one minute to complete using any internet connected device and does not collect any personal information. The data derived, however, may prove critical as ISPs compete for funding, because when conflicts arise the data may prove the level of service available at a specific address does not meet a minimum of 25 megabits per second (Mbps) download and 3 Mbps upload.

Take Indiana Speed Test

LigTel Communications is preparing to submit grant applications to help fund the expansion of fiberoptic Internet across rural Noble County. The company is asking rural residents and businesses to take their survey and submit evidence (screen shots) of speeds that are not consistently a minimum of 25/3 as well. They caution to ensure mobile devices are connected to the address's wifi, not set to "data", when taking the speed test. Results of this survey will be submitted with grant applications to strengthen the case for the expansion of fiberoptic internet.



Construction begins on new shell building in Kendallville

Phase I construction of a 75,000 square foot, widespan design steel building, expandable to 100,000 square feet, featuring 30' ceilings, LED lighting inside and out, 3-Phase electric service, 6" thick concrete floor, and more, is expected to be completed by January 22. The building will be located just off SR 3 south of Kendallville on Ohio Street. Leatherman Construction Inc. (LCI) is the contractor.
