How local taxes support economic development

In 1973, the Indiana General Assembly enacted legislation that provided each of its 92 counties the option to adopt a new, local income tax called a County Adjusted Gross Income Tax (CAGIT). In 1984, the legislature enacted another option tax, called the County Option Income Tax (COIT). Then, in 1987, a third income tax option was introduced, this one specifically to spur economic development. It is called the County Economic Income Tax (CEDIT). CEDIT was enacted to stand alone or supplement either or both of the first two taxing options.

Funding available for childcare benefits for employees

The Indiana Family and Social Services Administration's Office of Early Childhood and Out-of-School Learning has announced new funding to mobilize employers and communities to create and expand child care offerings. In partnership with the Indiana Chamber of Commerce, with support by the Indiana Manufacturing Association, the Employer-Sponsored Child Care Fund is part of Governor Eric Holcomb's 2023 Next Level Agenda. Under this new grant program, up to \$750,000 can be awarded to support employee's child care needs. Thrive by 5 Serving LaGrange and Noble Counties encourages employers to learn more about the grant here. Thrive by 5 plans to apply on behalf of employers to develop a matching grant fund for capacity building locally. Busche is back, with a new venture

Nick Busche, founder of Busche Performance Group, a company that grew into one of the largest aluminum casting and machining suppliers in North America, is launching a new venture at the site of the former company's

headquarters east of Albion. Terra Supreme Battery will manufacture Group 31 batteries and is projected to create 65 new jobs by the fall of 2024. Noble County Council members recently approved a 10-year tax abatement for the company with \$22.6 million being invested in manufacturing and logistics equipment. Busche's application for the tax break indicates an annual payroll of \$4.5 million based on an average

wage of more than \$70,000 per job. Busche co-founded Terra Supreme Battery with Benny E Jay of Texas.

Heartland BioWorks wins designation worth millions

Another major win for Hoosiers has come with the designation of Indiana's Heartland BioWorks as a Regional Technology and Innovation Hub. Senator Todd Young authored the program as part of the CHIPS and Science Act to help spur more innovation and enable Indiana to compete with the likes of Silicon Valley. The designation could lead to millions of dollars in federal investments and attract more private investment in biotech research and development across the state.
